

## Grand Teton Relay Participation Waiver of Liability and Release Agreement

I, the undersigned to this Waiver of Liability and Release Agreement (the "Release"), desire to participate in the Grand Teton Relay road relay, and all events associated with the relay, scheduled for August 19-20, 2016 (collectively, the "Relay"). I understand and recognize that there are significant risks in running and participating in the Relay, and other inherent risks of activities of this nature, known or presently unknown, which are too numerous to list completely, but which could include falls, contact with other participants or vehicles, the effects of the weather, including high heat and/or humidity, low temperatures, traffic and conditions of the road, contact with wildlife, and other matters, which could result in property damage, and/or serious bodily injury or medical conditions. I represent and warrant that I have sufficient experience and understand the inherent risks and dangers involved, and as a condition of, and in consideration for, being allowed to participate in the Relay, I agree that I will not enter and run unless I am medically able and properly trained, and that I will abide by any and all instructions and directions from race officials, including any decision relative to my ability to safely complete the run.

Having read this Release and knowing these facts, and as a condition of, and in consideration for, being allowed to participate in the Relay, I assume all risks associated with running in the Relay, including but not limited to those referenced above, all such risks being understood and appreciated by me, and for myself and my heirs, assigns, representatives, executors and administrators, and anyone entitled to act on behalf of me or my estate, I hereby waive, release, and forever discharge Grand Teton Relay, LLC (the "Organizer"), its agents, the state of Idaho, the state of Wyoming, Freemont County, Idaho, Teton County Idaho, Teton County, Wyoming, USATF, and all sponsors and suppliers of the Relay, any other person assisting with the Relay, agents, servants, employees, and any successors and assigns of each of the above, from all claims or liabilities of any kind arising out of my participation in the Relay, even though the liability may arise out of negligence or carelessness on the part of the persons referred to in this Release. I further agree to hold harmless and indemnify the Organizer and all of the other persons referred to in this Release of and from any claims that may be made against them arising out of my participation in the Relay. I also am signing a separate Acknowledgement of Risk with respect to that portion of the Relay that is on Forest System Lands, and understand and agree that this Release will apply to all portions of the Relay which are on non-Forest System Lands.

I also grant the Organizer my permission and consent for the use of my name, likeness and/or image, including any photographs, motion pictures, recordings or any other record of my participation in the Relay, for any legitimate purpose. I understand that if the race is canceled because of circumstances beyond the control of the race committee and sponsors, including, but not limited to unsafe weather conditions, my entry fee will not be refunded. If I am registering a child under the age of 18, I represent and warrant that I am the parent or legal guardian of that child and have the legal authority to enter into this Release on their behalf, and by signing this Release I agree that the terms of this Release shall apply equally to all Registered Parties.
